# Minutes from Eureka County Television District Meeting January 13, 2023

- **a.** Roll Call Establish Quorum *Vice President Klatt established a quorum with 3 present and 1 on conference call.*
- **b.** Pledge of Allegiance *led by Member Moylan*
- **c.** Approve meeting agenda as presented or with changes as needed. *Member Brown motioned to accept the agenda as presented, Member Moylan seconded, approved (3-0) Member Rebaleati abstained.* **(For Possible Action)**

- **b.** December 23, 2022 *Member Brown motioned to accept both sets of minutes, Member Moylan seconded, approved (3-0) Member Rebaleati abstained.*

## IV. Discussion / Action Items (For Possible Action)

- a. Discuss, approve or deny the proposed budget and capital outlay for FY 23-24. (For Possible Action) Secretary Hilyard explained that she had doubled the salary and increased the employee benefits by 4 times as she didn't know what they are. Member Rebaleati explained that the Employee Benefits is where Unemployment and Workmans Comp. costs are recorded. It was decided that the amount from last year should only be doubled. Secretary Hilyard explained that she added 5% to the rest of the items for inflation. The \$10,000 for cameras at each site will cover the 3 cameras planned for each site and some left for additional cameras if deemed needed by the Board and the Maintenance Contractor. Member Brown motioned to accept the tentative budget as presented, Member Rebaleati seconded, approved (4-0).
- b. Discuss how Eureka's television service has been and if any information on weather the viewers want good reception of Channel 2 or keep the iffy reception so they can have the Las Vegas station when it happens to be coming in. (For Discussion Only) The general consensus from talking to Eureka viewers is to have good reception on Channel 2 and let the Las Vegas station go. The Eureka Board members will keep poling the viewers to be sure that is what is wanted.

- c. Discuss changing the meeting time and/or the day of the week to make Fridays more open. The 1:00 P.M. meeting ruins the day for other plans. The members discussed what time to have the meetings and what day. It was decided that Fridays was the day and that 10 AM is a good time. Member Brown also suggested that we have every other meeting in Eureka but we will see how President Leppala's health is and when he will be back before we decide on alternating the meeting sites. Vice President Klatt designated that the February 10, 2023 meeting will be at 10am in Crescent Valley and we will vote to keep the time and site swapping then.
