CALL TO ORDER

The Board of Eureka County Commissioners met pursuant to law on January 6, 2025. Present were Chairman Rich McKay, Vice Chair Marty Plaskett, Commissioner Mike Schoenwald, District Attorney, Ted Beutel and Chief Deputy Clerk Recorder, Brandy Mahoney. The meeting was called to order at 9:30 a.m. The interactive video conferencing system was connected between Crescent Valley and Eureka for the entire meeting.

Commissioner Plaskett motioned to approve agenda with the tabling of the Kenny Sanders Resolution item, Commissioner Schoenwald seconded the motion, all in favor, motion carried 3-0.

The meeting began with the pledge of allegiance.

They had the rubber pot out at the airport; they borrowed it from NDOT.

PUBLIC WORKS - Jeb Rowley, Public Works Director

Public Works Director, Jeb Rowley reported that the new mechanic's first day was that day, they will be interviewing for the public works technician later in the week. Municipal Well #2's pump is down, and they need a bigger crane to finish setting it the rest of the way, they are looking to finish by the end of the week. They are nearing completion of the boy's locker room at the swimming pool. They will be working on fixing light poles in the Eureka Canyon subdivision. Jeb reported that they have been looking at the budgets and preparing for that presentation. Jeb also reported that they held a LEPC exercise on the 18th and had a great turnout and they were able to produce an action report.

LOCAL EMERGENCY PLANNING COMMITTEE - Jeb Rowley, Chairman
